It has now been a year since the Congress party has come to power in this state. During this year-long Congress rule, it has been trampling on all the promises it made to the people, instead working aggressively for the interests of the corporates. The fundamental rights of the people and their very right to life are being threatened. In order to tie the state to corporates, they are implementing an easy trade policy in the name of economic development and are inviting large-scale investments from corporate companies.

In order to globalize Hyderabad, and in the name of building world-class Hyderabad (Global Hyderabad), the River Belt Development Corporation Limited (MRDCL) and the operational department HYDRA (Hyderabad Disaster Response and Asset Protection Agency) are being formed under the names of beautification of the Musi River, and river bed cleaning. In reality, this means that illegal constructions in Hyderabad are rising, while they are continuing Bulldozers' Raj by giving them wide powers.

They have invited the investments of thousands of crores of rupees from domestic and foreign corporations to build historical monuments by promising to develop the Musi River as a tourist destination. No sanitation measures are being taken to provide clean drinking water to the people living in the Musi River area. Pollution and dirty water generated from various waste materials emitted from industries are reaching the Musi River. Without taking preventive measures and purifying the water, the people of the Musi River catchment area are being blamed for all this.

In Hyderabad city, the middle class and poor people, who have been living there for decades, have been declared as squatters, leaving behind the large, large floors of illegal buildings built by big individuals and organizations, justified in the name of replacing illegal structures. Setting aside legal permissions and without giving any prior information or notice to the people, they are violently and suddenly coming night after night with bulldozers to demolish the houses built by the hardworking people, thereby depriving the common people of their right to live.

The state government has given permission for the construction of a VLF (Very Low Frequency) Communication Transmission (Navy Radar) station at Damagundam in Pudur mandal of Vikarabad district. 2900 acres of land have been handed over from the Reserve Forest for the construction of the Navy Radar station at Damagundam. This will destroy the natural reserve forest of Anantagiri hills. Thousands of people who depend on the forest for their livelihood are losing their right to live.

They have planned to build pharma city in Lagacharla village of Dudyala mandal of Kodangal constituency and loot the farmers' crop lands along with the local natural resources. The peasants

whose lands are being looted have taken up a militant movement in a life-and-death struggle. The administration of Lagacharla village has distorted this justified struggle and framed cases against the peasants.

In Adilabad district, the people took up the path of movement against the ethanol industry. The teacher who led the movement was suspended from duty in order to suppress this people's movement. Those who stood on the side of the people and democratically questioned these actions are being silenced forcibly.

As soon as the Congress party came to power, the Brahmanical Hindutva central government, in alliance with the state government, launched fascist attacks on the revolutionaries with the aim of eliminating the Maoist party. On the orders of the Congress state government, hundreds of forces were deployed towards Dameratogu villages of Gundala mandal in Bhadradri Kothagudem district and both, comrade Nallamari Ashok, as well as six revolutionaries at Raghunathapalem village of Karakagudem mandal, were murdered by these reactionary forces in the same district.

The destruction and undemocratic rule prevailing in the state today is not just due to the negligence or irresponsibility of the central governments. Chief Minister Revanth Reddy is showing great zeal to prove that he is their trusted pawn, purposefully seeking the profits of the corporates. He is getting a notable share of their investments and huge commissions.

People! Condemn the pro-corporate, anti-people, undemocratic, brutal rule being imposed by the Congress government in the state. Oppose the barbaric bulldozer attacks being carried out by Hydra on the middle class and poor people in the name of illegal constructions and cleaning the Musi River. Take up militant movements in an escalating manner, strongly opposing the Navy Radar Station and the pharma city, which are destroying the environment.
